Commitment to reducing emissions

IQVIA is taking steps to support in our emissions reduction efforts. As part of our Sustainability program we are taking actions noted in this Carbon Reduction Plan. In 2021, we committed to achieving an approved sciencebased target by the end of 2023 to reduce our environmental footprint and progress towards becoming a net zero business. In December 2022 we submitted our near-term and long-term targets to the Science Based Targets initiative for validation. Our long-term target includes the commitment to become net-zero by 2050 in line with the Paris Agreement. In October 2023, our targets were approved by the Science Based Targets initiative. Our latest progress against our Science-Based targets can be found in our latest Sustainability Report.

Baseline Emissions Footprint

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

Additional Details relating to the Baseline Emissions calculations.

Our baseline year has been recalculated and updated from 2017 to 2019. Our base year recalculation policy aligns with the GHG Protocol Corporate Standard. We assess all relevant changes which impact on our emissions baseline for significance to ensure that our baseline year emissions continue to be directly comparable with our reporting year emissions. We have recalculated our baseline year as a result of expanded accounting of Scope 1 and 2 emissions.

Carbon Reduction Projects

In alignment with United Nations Global Compact Sustainable Development Goal #13, Climate Action, IQVIA have achieved an approved Science Based Target in October 2023. The IQVIA Letter of Commitment to the Science Based Targets initiative (SBTi) was published on 24 August 2021. The Science Based Target outline specific actions to be taken to becoming a net-zero business at a corporate level.

As Participant members of the United Nations Global Compact, the third annual Communication on Progress was published on 31 July 2024 The Communication is available on IQVIA.com and sets out a description of actions taken or planned to implement the Ten Principles of the UN Global Compact, as well as a measurement of the outcomes of actions.
